ELECTRIC

Meters are read on the last day of the month and terminating service. The bills are mailed by the 5th of the month and payable within 20 days without penalty. The late charge is 1.5% per month.

Electric rates are:

Residential: \$2.75 service charge
plus .0405 per kwh
Commercial: \$3.15 service charge
plus .0515 per kwh

Reconnect fee is \$35.00.

We are allotted a certain amount of hydropower from New York Power Authority. Any amount we have to buy on the open market as well as wheeling and other costs are prorated through the fuel adjustment charge (PPC) on your electric bill.

WATER

Meters are read on the last day of the month and terminating service. The bills are mailed by the 5th of the month and payable within 20 days without penalty. The late charge is 10%.

Water rates are:

Village: Minimum charge- \$28.00. Each additional 1,000 gallons is \$3.00. Water Debt is \$7.40 a month per housing unit.

Town: Minimum charge- \$47.00. Each additional 1,000 gallons is \$5.00. Water Debt is \$11.76 a month per housing unit.

Disconnect or reconnect fee is \$50.00 for months May-Oct/\$75.00 for months Nov-April.

Water is a precious commodity so please watch for leaks and for ways to conserve.

SEWER

Meters are read on the last day of the month and terminating service. The bills are mailed by the 5th of the month and payable within 20 days without penalty. The late charge is 10%.

Sewer rates are made up of two parts:

The sewer debt cost is \$31.80 per month per unit.
The Operation and Maintenance cost is \$7.40 per 1,000 gallons as read by the water meter.
