Public Comments:

R. Uptegrove asked if the Town has any authority over the creeks within our Town.

Sup Tarbell stated that Wyoming County and Soil and Water and the DEC take care of waterways within towns.

M. Hotchkiss stated that R. Domroes had passed away and that she is having a plague made to place on the bench that she always sat at.

Sup Tarbell stated that the water and sewer systems are over 30 years old and that there are some pressure issues. He has been in contact with J. Smith from Municipal Solutions to go over options that the Town has to update and expand the Silver Lake Water District.

- J. Smith from Municipal Solutions spoke to the Board regarding the different options of obtaining funding for the work that needs to be done on the Silver Lake Water District. He feels that the best option would be a rolling Bond Anticipation Note but would like to speak with Tom Carpenter from Clark Patterson Lee to get his opinion.
- F. Vitagliano asked how many water customers are in the District.
- J. Smith Stated that altogether there are 233 and that the cost would only be spread out to the residents within that District. He also stated that worst case scenario the project would cost \$1 Million which would cost the residents about \$190 additional per year for their water bills, which is still well below the average.

He stated that by approving the resolution signed this evening it would also include an additional \$1000 fee for Clark Patterson Lee.

A motion was made by Coun Monteleone, seconded by Coun Vitagliano giving permission for Sup Tarbell to sign a contract with Municipal Solutions and Clark Patterson Lee to move forward with the preparation for a Plant Grant Application and Application for Rural Development Funding and a full Application for Rural Development Funding and General Financial Services in regards to the maintenance of the Silver Lake Water District.

He also stated that every 9 years we are required to do an Asbestos Waiver which is a form that he needs to sign and submit to the Wyoming County Department of Health stating

that we have no asbestos in our water lines. J. Koch also stated that we are down to one pump at Pump Station 6 because the check ball is stuck. Caulkins Technical will be out by 4/28/15 to remedy the situation; they will look at the Pump Station by the Pro Shop at that time also as there are corrosion issues down there.

- J. Koch also reported that on 4/21/15 the MultiSmart will be installed at Pump Station 7 and that he ran a dedicated circuit for the Fire Suppression System at the Government Center.
- D. Nourse presented his Highway Report. He stated that they are getting the summer equipment serviced. He also stated that they have taken a couple of trees down on Swyers Road and that there are several more that need to be removed in other areas of the Town. He is hoping to remove 5 trees a year.

Sup Tarbell stated that he has noticed that the heating bills have lowered significantly at the Highway since the building has been insulated. He stated that it has been a big improvement down at the Highway under Darryl's leadership.
