- J. Koch presented his Water/Sewer Report. He stated that there had been a water main break on Genesee Ave that was repaired. He also stated that he will be ordering 2 Multi Smarts for Pump Station 4 and Lift Station 7 at the cost of \$21,866.40, this was previously budgeted for.
- D. Nourse presented his Highway Report. He stated that he replaced some lighting in the shop and will be reimbursed through the Village using the CEEP program. He also stated that they have sanded and painted the doors at the shop.

Dep Sup Klein asked where they stood as far as salt/sand compared to last year.

- D. Nourse stated that they have probably used \(\frac{1}{4} \) compared to last year.
- T. McQuillen presented her Assessor's Report. She stated that the project is winding down and that she will be holding a Tax Payer Information Session on Saturday, February 20, 2016 at 10AM. assessments will go out in letter form after the session on Saturday. She also explained the Ag Exemption that would be applied to the fire district if adopted. She stated that it would decrease the amount that farmers would pay on their vacant tillable farmland and that it would shift the tax burden to the rest of the residents and it would increase their fire tax rate 6 cents per thousand.

Coun Vitagliano was not present but sent the following:

I will not be at the board meeting Thursday but want to express my concerns about this resolution. I am against it for several reasons. First and foremost I find it unfair that some town parcels would not pay for our \$70,000 fire contracts, and the balance of taxpayers pay the additional to offset. Why have non-building vacant ag parcels be exempt from paying for fire service? The fire depts would still respond for a grass fire or farm equipment burning in those fields. Also why would only ag classified parcels get the exemption--what about 50 acres of commercial or recreational zoned property? Although this exemption on 220 parcels appears not to be much money today based a \$70,000 fire contracts, how much more will the rest of the taxpayers pay in five years when the contracts are at 100,000. Tina told me that once the resolution is passed it can never be rescinded. I'm not sure where this idea came from other than the fact that the town of Perry passed it, and Tina is assessor for both townships. I called around other towns in Wyoming County and it doesn't appear to be on any others radar. If the state wants to pay the Town for this ag exemption, as opposed to our other taxpayers paying it then I might be in favor. Vicky even though I will not attend the meeting, I asked you put my concerns and opposition to this resolution in the minutes. I welcome any other comments about this from the rest of the Town council.

Dep Sup Klein stated that this type of land does not need as much protection as the risk value is not there compared to residential areas.

Coun Hurst stated that he does not like the idea of the burden being put on everyone else.
