Mayor's Report The Republican Caucus is January 26th at 7:00 pm.

Our Attorney asked about sidewalks but we have nothing new to tell him.

The Mayor attended a school board meeting to discuss the school starting EMT classes. The age for starting training has been dropped to 16.

Tr Bannister discussed standing water on Liberty Street. It has always been wet there, when we continue tiling the park that may take care of some of the problem.

<u>Supt's Report</u> They are still picking up Christmas trees.

The Supt stated that the materials to replace the three doors and windows in the park pavilion and putting up new texture 111 will cost approximately \$2,600. The Board discussed different options including using thicker plexiglass and pricing hardiboard instead of texture 111.

Electric Foreman's Report Jeremiah and Justin passed Electric Line School.

They have put up four new electric poles in the Village Park. Four trees had to be cut and others trimmed. Sun Dor's request for a bigger electric service was discussed. The transformer cannot be put on a platform, it must be put on a pad mount. They need to give a detailed list of everything that will be running, so we know what they need. Then we will need to have J Tucker here for an engineering study to determine if we can provide their needs. That will cost approximately \$2,400. Sun Dor will have to pay for all the upgrades including the Engineers fee. We will also need to meet with Beardsley's who will be doing the electrical for them. The Mayor will meet with J Pierce of the County after the determinations are made.

<u>Clerk's Report</u> A <u>motion</u> was made by Tr Bannister, seconded by Tr Washburn, for one person to attend Water School in Geneso on 4/23.
