He will be working for two weeks from 8:30 to 11:30. The new chipper box will be completed this week. Chips will be picked up next week prior to leaves being picked up. PESH-work at the shop is being done. The #3 stone that was placed on the shoulders on Mill St seems to be holding up very well. The sidewalk work on Beechwood Ave will be completed this week. The County looked at the ditch on Spring Street on Monday – they will not be able to use their bulldozer so will return with their draught. We're looking for someone to remove the beavers at the end of Spring St.
