Perry is requesting our sludge for composting; we are looking into how to transport it. NYS DEC is looking for municipalities to participate in the Municipal Sewage System Asset Management (MSSAM) Pilot Program. Larson Design will help us participate at no cost to us so the Board agreed to be involved. The Board discussed trying to get grants for several different projects. The Supt is looking into what is involved with Confined Space Training.
