Supt's Report:

A motion was made by Tr Bannister, seconded by Tr James, to adopt the following resolution:

WHEREAS, the Board of trustees of the Village of Castile, New York, is a municipal member of the New York Municipal Power Agency, and

WHEREAS, the New York Municipal Power Agency Semi-Annual Meeting has been called on October 24, 2018 to be held at the Solvay Fire Department, 1925 Milton Ave., Solvay, NY, 13209 and,

WHEREAS, in accordance with the bylaws of the New York Municipal Power Agency, each municipal member may cast one vote on each transaction properly brought before this meeting.

Now therefore be it resolved, that (the NYMPA Board of Directors or another delegate as the municipal may desire) James Nauert be and is hereby designated as the accredited delegate of the Village of Castile, New York.

The Board responded that we will continue to assist with Mutual Aid, but we respectfully decline to Bid and directed Clerk Gozelski to have the office send a letter of declination.

Supt Wright informed the Board that the DPW employees had received CPR training with Silver Springs as a part of our Shared Services agreement.

Supt Wright recommended that we purchase AED's (Automated external defibrillator) for both bucket trucks.

A <u>motion</u> was made by Acting Mayor Dennis Miller, seconded by Tr James, to approve a purchase of an \$1,100 AED unit for a bucket truck.

Supt Wright reported they are done shimming on the streets. In the coming year he would like to look into trying NOVA chipping instead. It will be a less expensive but more effective than shimming for the Village.

The Board directed Supt Wright to fix the road as per his discretion in regards to NOVA but to take all precautions for drainage.

Supt Wright would like to test the NOVA chipping at the driveway out in the Village Park.

Tr Bannister asked him if speed bumps could be put in place if we do this project.

Supt Wright checked into the Tariff, in reference to W. Bliss question on metering. Being that we are Municipal Electric we do not have to provide net metering.

Clerk's Report:

Bank reconciliation was submitted for September 2018.

Clerk Gozelski informed the Board that we received our Contract BAN number for the \$50,000.00 awarded from Senator Gallivan through DASNY on October 15, 2018.

A <u>motion</u> was made by Tr Reed, seconded by Tr Bannister, to pay our 30/70 share of the Great Lakes Building Systems Fire Systems Integrators quote.
